Team Rebates

Kanuga is proud to offer a team rebate for groups of three or more participants registering together for Kanuga-sponsored conferences held June 14 – August 28, 2009. This offering allows those registering together to do so at a reduced rate based on the size of the group. In order to qualify for the rebate, the following guidelines must be followed. **Teams must register together, not as individuals.**

Team Organizers: Please read the guidelines listed below, complete the attached form and return to Kanuga Reservations with completed conference registration forms and non-transferable, non-refundable deposits. This form is also on our website (at the bottom of the home page, click on Download Forms).

Team Guidelines:

1) A team consists of three or more conference participants attending Kanuga-sponsored summer conferences together during one week. They may attend any of the Kanuga-sponsored events during that week. Youth attending JYP or SYP can be included in a team. Children, babysitters and non-participating spouses accompanying conferees cannot be included as team members, nor can conferees receiving scholarships granted by Kanuga.

2) The team organizer will recruit the team and list all requested information on the attached list. ***Individuals already registered may not change to team status.***

3) The team organizer will secure and send with this team rebate form a list of *completed registration forms* and a \$50 non-transferable, non-refundable deposit for each person. Kanuga reservations will advise the organizer if space is not available in the conferences. If a team member is bringing other family members, they should be listed on the registration form, but not on the team form. The deposit amount should reflect a \$50 non-transferable, non-refundable deposit for each family member over three years of age.

4) **Team Organizers Please Note:** The team organizer agrees to collect all balances due and return them to Kanuga by May 15, 2009 for the June/July conferences, except by May 28, 2009 for the Renewal Conference. Balances for the Liturgical Arts Conference are due by July 17, 2009. ***Any balance not included will remove the participant from team eligibility.*** If a participant cancels, for whatever reason, the team status may change.

5) Kanuga will mail the rebate check to the team organizer after the conference week has ended. The team organizer will distribute the rebates to team members. If the team organizer is not a team member, the larger rebate may be used for any member.

6) Rebates will be calculated using the double occupancy rates.

7) Kanuga's receiving the Team Rebate form and payment by the deadline does not ensure space availability in the conference. Please send all materials as early as possible.

Teams of 6 or more conferees a 50% rebate for team organizer and 15% for others.*

Please print clearly and return to Kanuga Reservations with completed registration forms and a \$50 non-transferable, non-refundable deposit per registrant. All balances are due at Kanuga on May 15, 2009 for the June and July conferences, except May 28 for the Renewal Conference. Balances for the Liturgical Arts Conference are due by July 17, 2009. Payments and registrations received after that date are not eligible for team rebates. (Please make copies if additional pages are needed.)
